YAS Final Two Year Operational Plan 2017/18 – 2018/19

1. PURPOSE/AIM

1.1 To present the final, approved YAS Operational Plan 2017/18 – 2018/19 narrative to the Board of Directors, following submission to NHS Improvement (NHSI) on 23 December 2016 in line with the National Planning Guidance.

2. BACKGROUND/CONTEXT

- 2.1 The Joint Planning Guidance for 2017/18 2018/19 was released by NHS England and NHS Improvement on 23 September 2016.
- 2.2 In line with the guidance the narrative draft plan was submitted to NHSI on 24 November 2016. The final YAS plan was required to be submitted by 23 December 2016.
- 2.3 The narrative operational plan sets out the Trust's two year plan between 2017/18 2018/19, incorporating key summary information from the finance, workforce and triangulation worksheet submissions.
- 2.4 The narrative plan is based on an outline template of requirements from NHSI and was approved as the Trust's final plan, by the Board of Directors on 22 December 2016.

3. PROPOSALS/NEXT STEPS

3.1 The Trust's final, approved two year Operational Plan 2017/18 – 2018/19 was successfully submitted to NHSI on 22 December 2016, ahead of the required submission deadline.
