1. PURPOSE/AIM

1.1 The aim of this paper is to provide the Trust Board with an update on the activities of the Audit Committee, and to provide assurance that the Committee is complying with its purpose as set out in its terms of reference.

2. BACKGROUND/CONTEXT

- 2.1 At the Trust Board meeting on 24 September, the Audit Committee Chairman provided a verbal summary of the key matters arising during the 16 July Audit Committee meeting. The draft minutes of the 16 July Audit Committee meeting were subsequently considered and approved at the Audit Committee meeting on 17 October.
- 2.2 The draft minutes of the 17 October Audit Committee meeting will be considered at the next Audit Committee meeting, on 10 December.

3. MATTERS TO BE REPORTED

 - the approved minutes of the 16 July Audit Committee meeting
 - a report of the key matters considered, discussed and agreed at the 17 October Audit Committee meeting

- 3.3 Key matters arising at the 17 October 2013 Audit Committee meeting

The Audit Committee:

- received updates representing good progress in pursuing outstanding actions on the Audit Committee Action Log.
- received an update on Risk Assurance Reporting, including the Board Assurance Framework and the Corporate Risk Register, providing satisfactory assurance.
- considered and provided feedback regarding the latest version of the Trust's Risk Management & Assurance Strategy.
- received and considered an Audit Committee Assurance Report from the Finance & Investment Committee which provided assurance regarding the management of financial risks and highlighted key matters to be discussed and considered at that Committee's 12 November meeting.

- received a Charitable Funds Committee Risk Assurance Report confirming that Committee's proposed approach to providing on-going risk management assurance to the Audit Committee.
- received a Quality Committee Assurance Report providing assurance regarding the management of Quality risks.
- received further assurance from the Executive Director of Finance & Performance and from Internal Audit regarding the accuracy and completeness of the Trust's Integrated Performance Report (IPR). The planned further improvements to the IPR, and the need to maintain accuracy and completeness were noted.
- received and discussed an effectiveness report and a transparency report presented by the Trust's external auditors, Deloitte. The Committee was assured as to the adequacy of the service provided by the external auditors.
- received an Internal Audit Progress Report, providing an update on work according to the agreed Internal Audit Plan and providing assurance in respect of auditable areas reviewed.
 - Concern was expressed by Committee members regarding the 'limited assurance' findings of an internal audit review of the administration of Community First Responders. The Chairman of the Quality Committee undertook to investigate the findings at the 12 November Quality Committee meeting.
 - Concern was also expressed by Committee members regarding further 'limited assurance' audit findings relating to the Trust's recruitment processes and controls. A presentation from the Executive Director of People & Engagement has been requested at the next Audit Committee meeting.
- received a progress report from the Local Counter Fraud Service, confirming the investigations currently in progress.
- received and approved a new Anti-Fraud, Bribery and Corruption Policy for the Trust, in the form of a new template provided by NHS Protect.
- reviewed management progress in acting upon audit recommendations.
- reviewed and accepted a report in respect of SFI waivers and contract award activity over £100k
- reviewed and approved the Schedule of Losses and Special Payments for Quarter 2, 2013/14.
- considered the feedback from the NHS TDA resulting from observation of the 16 July Audit Committee meeting.
