1. SUMMARY

1.1 The purpose of the paper is to provide the Board with an update on the Trust's position with regards to its premises following the letter received from NHS England on 5 September 2023 and the proposed next steps for tackling reinforced autoclaved aerated concrete (RAAC).

2. BACKGROUND

2.1 In response to the letter received from Jacqui Rock, Chief Commercial Officer and Dr Mike Prentice, National Director for Emergency Planning and Incident Response, NHS England on 5 September 2023 with reference to the new guidance published by the Department for Education in relation to the approach to the presence of RAAC in the school estate. This generated heightened public interest for RAAC in the NHS estate. The letter requested that NHS providers reiterate their position in the NHS estate, and to outline any actions that should be taken to assure the Board as far as possible that RAAC is identified and appropriately mitigated, to keep patients, staff and visitors safe.

3. THE TRUST'S ESTATE

- 3.1 The Trust's estate includes circa 109 buildings, with the majority built during the period RAAC was used. However, RAAC is known to have been used for larger buildings such as hospitals and schools predominantly for walls and ceilings. The Trust has undertaken 'condition assessments' over the years. The last condition assessment was undertaken in 2022, which concluded that there was no evidence at that time to suggest that there where structural defects relating to concrete in the Trust's building fabric.
- 3.2 Condition assessments do not include a full intrusive survey and for buildings to be fully assessed this would require a full structural assessment to be undertaken, which would incur additional costs.
- 3.3 The Trust's internal Estates Team have received the guidance issued in August 2023 from the Department of Education (Reinforced Autoclaved Aerated Concrete (RAAC): Identification guidance) and will continue to monitor the quality of buildings and concrete specifically in line with this guidance. It is worth noting that only five of the Trust's buildings has concrete at the heart of their construction (Walls and Roofs) with the remaining building are of traditional building methods of brick, timber, steel and slate.
- 3.4 In order for the Board to be assured, it is recommended that a full report is provided to Finance and Performance Committee in response to this letter with assurances/risks/mitigating plans provided to the Board thereafter.

4. FINANCIAL IMPLICATIONS

5. RISK

5.1 The condition assessments undertaken do not include a full intrusive survey and for buildings to be fully assessed this would require the Trust to commission a full structural assessment to be undertaken.
