## 1. INTRODUCTION

1.1 This report provides an update on developments relating to Board governance.

## 2. BOARD GOVERNANCE UPDATES

# **Trust Establishment Order**

- 2.1 The Trust is awaiting approval of its new Establishment Order from the Department of Health and Social Care (DHSC). When approved, the new Establishment Order will increase the number of Non-Executive positions on the Board of Directors from six (Chair plus five) to seven (Chair plus six).
- 2.2 Final Ministerial approval for the new Establishment Order is expected soon. The latest advice from DHSC (received 12 May) is that the Trust can reasonably expect Ministerial approval for the new Establishment Order to take effect from 01 July 2025.

# **Recruitment: Non-Executive Directors**

- 2.3 The latest campaign to recruit up to two new Non-Executive Directors closed on 13 May 2025. The Trust has received 26 applications.
- 2.4 Interviews are scheduled for 17 June and will include a stakeholder panel and formal interview.

# **Recruitment: Medical Director**

2.5 Interviews for the position of Medical Director were scheduled to take place on 20 May.

## **Internal Audit Reviews**

2.6 In September 2024 the Board was informed that three internal audit reviews relating to Board governance arrangements were due to take place during the second half of 2024/25. All three reviews have concluded and the reports have been issued, with the following outcomes:

# **AdminControl Implementation**

- 2.8 The Trust has commenced implementation of AdminControl, the portal that will deliver efficiency and productivity gains to the administration of Board and committee meetings.
- 2.9 AdminControl is being introduced in phases and is being used first to manage the meeting of the Finance and Performance Committee meeting on 20 May. The system will be rolled out to other meetings during the next few months.
